Quam Thrives Amid The Globalisation of Financial Markets

**Its Affiliate MAC Capital Advised
First Chinese Company's Listing in Dubai**

(28 September 2008, Hong Kong) – **Quam Limited** ("Quam", Stock Code: 952.hk), a prominent Hong Kong-based financial services group, is pleased to announce its affiliate, MAC Capital Limited ("MAC Capital"), which provides investment management, administrative and management services and advisory service on equity broking activities in Dubai, advised China Security & Surveillance Technology, Inc. ("CSST", NYSE: CSR) in regard to its successful application to list its shares on the Dubai International Financial Exchange ("DIFX").

CSST is principally engaged in the manufacturing, distribution, installation and maintenance of security and surveillance systems in the PRC, and was first listed in New York Stock Exchange ("NYSE") in October 2007. It expects to list its shares on DIFX on or about 13 October, 2008. In recognition of its recent achievements, on 21 September 2008, CSST was named to Forbes List of "Asia's Best 200 Under A Billion" which focuses on Asia - Pacific companies with sales US\$1 billion per annum.

Mr Robert W McMillen, the Chairman of MAC Capital, said, "MAC Capital is delighted to have advised CSST on this listing, the first listing by a Chinese company on the DIFX and also the first dual listing company in NYSE and DIFX. This will broaden CSST's share base and will extend the trading hours of its stock in a business day. It will also significantly improve the potential for branding of the company and its products in the UAE."

MAC Capital has previously advised on an equity private placement of shares in CSST to prominent business groups in Dubai, Sharjah and Hong Kong.

Mr Bernard Pouliot, the Chairman of Quam, is excited to know such remarkable accomplishment achieved by Quam's affiliate. He said, "MAC Capital's achievement proves that Quam is on the right track in the midst of globalised financial markets. Quam will continue its expansion overseas and capture the opportunity arising from it."

Quam currently holds 22.69% stake in McMillen Advantage Capital Limited, the holding company of MAC Capital, while MAC Capital itself is a member of the DIFX and regulated by the Dubai Financial Services Authority. As of 25 September 2008, CSST closed at US\$14.69 with a trading volume of 303,486 shares.
